There will be many privileges for LTR Visa holders :

- 10 years renewable visa with multiple entry
- 1-year report instead 90-day report
- Permission to work in Thailand (Digital Work permit)
- Family members can follow to Thailand
- Every nationality can apply for LTR Visa
- Fast Track at Suvarnabhumi Airport
- Other

Wealthy Global Citizen

Wealthy individuals holding at least USD 1 million in assets



Wealthy Pensioner

Retirees aged 50 years and older who have an annual pension or stable income

Remote workers working for well-established overseas companies



Highly-Skilled Professional

Experts in targeted industries working for higher education institutes in Thailand



Dependents

Spouse and children under 20 years old of LTR Visa holders (Maximum 4 dependents in total per one LTR Visa holder)

Requirements

Wealth Status & Investment

- At least **USD 1 million** in assets
- Personal income of a minimum of **USD 80,000/** year in the past two years
- Investment of at least **USD 500,000** in Thai government bonds, foreign direct investment, or Thai property

Health Insurance

- Health insurance with at least **USD 50,000** coverage or social security benefits insuring treatment in Thailand or at least **USD 100,000** deposit

Requirements

Wealth Status & Investment

- Personal income of at least **USD 80,000**/ year at the time of application
- In case of personal income below **USD 80,000**/ year but no less than **USD 40,000**/ year, applicants must invest at least **USD 250,000** in Thai government bonds, foreign direct investment, or Thai property

Health Insurance

- Health insurance with at least **USD 50,000** coverage or social security benefits insuring treatment in Thailand or at least USD 100,000 deposit

Requirements

Personal Income

- Personal income of a minimum of **USD 80,000/ year** in the past two years
- In case of personal income below **USD 80,000/ year** but no less than **USD 40,000/ year** in the past two years, applicants must have a **Master's degree** or above or own intellectual property or receive Series A funding

Current Employer

- **Public** company on a **stock exchange** or; **Private** company in operation for at least **three years** with combined revenue at least **USD 150 million** in the last three years

Experience

- At least **5 years** of work experience in the relevant fields of the current employment over the past 10 years

Health Insurance

- Health insurance with at least **USD 50,000** coverage or social security benefits insuring treatment in Thailand or at least USD 100,000 deposit

Requirements

Personal Income

- Personal income of a minimum of **USD 80,000/ year** in the past two years
- In case of personal income below **USD 80,000/ year** but no less than **USD 40,000/ year** in the past two years or before retirement, applicants must have a **Master's degree** or above in **science and technology** or special expertise relevant to the job assignment in Thailand

Current Employer

- Business in any targeted industries
- Higher **education** institution, **research** institution, specialized **training** institution, or Thai government agency

Experience

- At least **5 years** of work experience in the targeted industries **except** for applicants with a **PhD** or above in the relevant fields of the targeted industries or applicants working for Thai government agencies

Health Insurance

- Health insurance with at least **USD 50,000** coverage or social security benefits insuring treatment in Thailand or at least USD 100,000 deposit

Requirements

Family Member & Document

- Spouse and **children under 20 years old** of LTR Visa holders (Maximum **4 dependents** in total **per one** LTR Visa holder)
- Relationship Document

Health Insurance

- Health insurance with at least **USD 50,000** coverage or social security benefits insuring treatment in Thailand or at least USD 100,000 deposit

10 years renewable visa with multiple entry

- 5 years each stamp, following year in passport.
- 5-year length of stay per entry, extendable without the need to leave the country.

Visa Fee : THB 50,000 (one-time payment)

Every nationality can apply for LTR Visa



"Digital Work permit"

Permission to work in Thailand

Exemption from 4 Thais to 1 foreigner employment requirement ratio.



1-year report

90-day report extended to 1-year report.



Discount 17% **Personal income tax** for High-skilled professionals

Making things easier in taxing area.



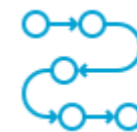

Pay to Gov's bank



The result will be informed via e-mail then can pay the fee THB 50,000

at Thai Embassies/ Consulates **in Overseas**

at Thai Immigration Offices **in Thailand**



+ Submit documents e.g., relationship & working docs



at Provincial Labour Offices in Thailand
