PERSONAL DOCUMENTS		
1.	<p>Copy of your current passport in which you wish to receive LTR visa with the validity of no less than 6 months when collecting LTR visa and at least 2 blank pages for LTR Visa and Stay Permit stamps</p> <ul style="list-style-type: none"> ● The SCANNED file must include biodata page and all pages with Thai immigration stamps (ARRANGE ALL VISA PAGES, IN THE FORM OF DOUBLE-PAGE SPREAD, IN CHRONOLOGICAL ORDER AND MERGE THEM INTO A SINGLE PDF FILE) ● Fingers must not appear on the photocopy ● If you have TM.47, please upload as a separate scanned file ● You may need to upload your old passport upon request for further checks (To be requested on a case-by-case basis) <p>Note: On the appointment date, a damaged passport may not be accepted and the applicant will not be allowed to receive LTR Visa. (Signs of damage include water damage, a significant tear or tears, torn out or missing visa pages, and unofficial markings). The Immigration officers reserve the rights to refuse services if a damaged passport is observed.</p>	○

International health insurance (travel insurance is unacceptable) policy covering entire course of stay in Thailand, with coverage for hospitalization treatment of no less than 50,000 USD and the remaining period of no less than 10 months</p> <p><u>OR</u></p> <p>B. evidence showing valid social security benefits which insures hospitalization and treatment in Thailand</p> <p><u>OR</u></p> <p>C. financial evidence showing a deposit of no less than 100,000 USD (or 25,000 USD in case of dependents only) which has been held for no less than 12 months at the time of application</p> <p>Note: Must be in or translated into English or Thai language only</p> <p>If you wish to submit (A.) later (however must submit before qualification endorsement process), please upload a signed the Document Request Acknowledgement Form for LTR Application</p>	○
3.	<p>Clear passport size photograph (Max 2 MB) WHITE background, face straight ahead to the camera, dressed in business attire (t-shirt is not allowed) without wearing glasses or headgear, taken within 6 months</p>	○

4.	T.M.6 Card (in case you have entered Thailand before July 1st, 2022 or entered through the immigration control at land border checkpoints and have received T.M. 6 card)	△

Copy of Thai Government Bond with the remaining maturity of no less than 5 years in applicant's name <u>OR</u> Company's shareholder list (Bor.Or.Jor. 5, not more than 3 months old) OR Securities Business License from The Securities and Exchange Commission In case of investing in venture company <u>OR</u> For freehold, copy of certificate of ownership of apartment/condo in applicant's name (Or.Chor. 2) AND copy of the sale and purchase agreement of the condominium unit (Or.Chor. 16 or 23) issued by Department of Land. For leasehold, copy of leasehold agreement issued by Department of Land. For investment on other properties such as owning a villa or a land lease, kindly submit the official sale and purchase agreement which indicates the purchase value of the property OR/AND the land deed which has your name as the owner of the Usufruct property right or leaser.	○

6.	Individual income tax return such as P.N.D. 90/91, BIR60, Form 1040, SA100, T1 General etc. showing income of no less than 80,000 USD per year in the past 2 years Note: Must be in or a notarized translation into English or Thai language only	○

7.	Evidence of global assets ownership of no less than 1 million USD (cryptocurrencies, tokens, amulets, arts, designer items, watches and jewelry are unacceptable) Note: Must be in or a notarized translation into English or Thai language only	○
ADDITIONAL INFORMATION		
8.	(To be requested on a case-by-case basis) A letter of verification issued from the country of his or her nationality or residence stating that the applicant has no criminal record (not older than 3 months) OR a Thai police certificate issued by Police Clearance Certificate Center, Special Branch, Royal Thai Police Note: Must be in or a notarized translation into English or Thai language only If you wish to submit this document later (however must submit before qualification endorsement process), please upload a signed the Document Request Acknowledgement Form for LTR Application	△
